Hereinafter referred to as Adopter with applied and approved status to adopt equines at above address.

- 1. Adopter agrees to abide by DTHR Adoption / Foster policy in its entirety.
- 2. Adopter understands that any and all equines adopted from DTHR remain the sole property of DTHR and may not be given away, transferred, sold or leased out.
- 3. DTHR may remove at any time and without explanation any DTHR owned equine from Adopters property without cause and without notice; without any recourse from Adopter.
- 4. If Adopter at any time ceases care of an equine adopted from DTHR, written notice must be given 30 days prior to date when equine has to leave and said equine has to be returned to DTHR.
- 5. Adopter agrees that should adopted equine be returned to DTHR no refunds will be made in any form.
- 6. Adopter agrees to comply with requests from DTHR for information about adopted equine.
- 7. Adopter is to provide hay, water, grain, wormer, vaccines, farrier work, timely veterinary care as well as safe living condition to adopted equine as outlined in Adoption / Foster policy as well as to follow veterinary directions as outlined in Equine Health Record
- 8. In the event of emergency, Adopter may move any equine in their care owned by DTHR to a safe location and will inform DTHR of the new location per telephone within 12 hours.
- 9. Adopter agrees, should euthanasia of a DTHR owned equine be necessary, DTHR is to be contacted immediately and can only be performed by Veterinarian who will sign DTHR Euthanasia form.
- 10. Adopter agrees that any authorized representative of DTHR may enter property without notice to determine any and all conditions of equines adopted.
- 11. Adopter agrees that neither DTHR nor its volunteers, employees or agents will be liable for any damages or injury caused to Adopter or any third person by the equine(s) owned by DTHR; including but not limited to damages or injured caused by ill behavior of said equine.
- 12. If Adopter is found in default in any conditions of this agreement and/or Adoption / Foster Policy or in the event of their death, Adopter hereby directs their estate to immediately return equine(s) owned by DTHR, back to DTHR and that said equine(s) are not part of their estate.
- 13. Adopter understands that by Adoption / Foster Policy Adopter has one week once equine is up for adoption to decide to adopt, and all forms need to be presented to DTHR for a adoption process.
